The loss of common land is an issue and I can tell you for a science based fact, over 75% of commoners are over the moon as it means the Duke will give the Graziers a load of cash for the association and the ground in and around the circuit will be grazed off as well giving the graziers a double whammy and other better grazing ground will be bought for the commoners. Triple whammy!! Loss of common land??? An issue we are trying to deal with in my land group, Common land needs to be used and made more effective not just left to be over grazed under grazed, flooded or drained. So already we at NRW are talking about a new way of thinking on this issue, but same old same old in this letter.

Peter, I can only but raise concerns to you as Chairman, in so far as I am sure everything has been done 'exactly' how it should have been, BUT.....we need to look at the whole picture which we have all agreed at Board level, social, economic and environmental. Neither of these points are mentioned in this letter as NRW. There is no point or little point in Board members pushing the new way of doing things if already the old ways are still being used or at least the perception is that they are being used.


